### 2020 Vendor Information

Market Square Night Markets will be held on Saturday evenings and select Fridays May through October 2020. Live entertainment is presented in collaboration with various community partners each week and the Market features a wide variety of artisans throughout the season.

**Dates:** Saturdays, May 16 – October 31, 2020

*Excluding August 15<sup>th</sup>, September 5<sup>th</sup> and 19<sup>th</sup> due to conflicting events in Market Square*

Fridays, June 5 & 12 and July 24, 2020

*Coinciding with the Three Rivers Arts Fest, and Pittsburgh Cultural Trust Gallery Crawl*

**5:00pm – 10:00pm in Market Square, Downtown, Pittsburgh**

#### Vendor Classification & Pricing:

**10x10' space\***

**MERCHANDISE VENDOR:** *Non-food items, hand crafts.*

*Examples: jewelry, apparel, decor, pottery, glassworks, beauty products etc.*

\$50/market

**PROCESSED FOOD VENDOR:** *Snacks & desserts, misc. food products.*

*Examples: jams, sauces, jerky, sweets, etc.*

\$50/market

**PREPARED FOOD VENDOR:** *Ready-to-eat meals and/or hot foods.*

*Examples: sandwiches, soups, any pre-cooked meals.*

\$75/market\*

**VEHICLE VENDOR:** *Merchandise Vendors operating from a truck/trailer are priced by 10-ft increments. Food Trucks are not permitted in Market Square*

\$50/market

**ALCOHOL VENDOR:** *Bottled alcohol products of any type: beer, wine, cider, mead, spirits, etc. Bottle sales and samples only, onsite consumption not permitted. See Alcohol Vendor Rules & Regulations for full requirements.*

\$80/market

\* Prepared Food Vendors will be given 10x15' space. Additional booth sizes & prices available in Application.

#### Vendor Qualifications:

- Applications received prior to March 20, 2020 will be reviewed for a first wave of acceptance. Applications must be submitted a minimum of two weeks prior to first requested Market date and will be considered on a rolling basis as capacity permits.
- Vendors are required to provide their own tents, weights, lights and all other materials essential to their setup and operation.
- Vendors must accept the terms of the [Vendor Participation Agreement](#) prior to being accepted.
- Vendors may apply to attend on select dates, subject to availability. Vendors are expected to be in attendance for all dates they are accepted for. Market is rain or shine, in the event of a dire weather forecast, Market may be cancelled or closed early
- For every four (4) Night Market dates attended during the 2020 season, vendors will receive credit for one (1) free Night Market date during the 2021 season, excluding Alcohol Vendors.
