

This year's Market will be open from **Friday, November 20 through Wednesday, December 23** which includes five weekends, Black Friday, and opens on Pittsburgh's annual *Light Up Night*®, which attracts hundreds of thousands of people to kick off the holiday shopping season.

The *Peoples Gas Holiday Market* is held in Market Square, the heart of Downtown Pittsburgh. This vibrant, centralized location is surrounded by restaurants, major office buildings, hotels, our magnificent Cultural District, and is adjacent to the landmark ice rink at PPG plaza. Holiday Market visitors experience a wonderland of Alpinestyle wooden chalets as they stroll through the illuminated square, each chalet brimming with high quality holiday gifts. You can also count on nightly crowds drawn to the *Market Square Season of Lights* dancing light show.

- Part-time Vendors may request specific dates, subject to approval and availability
- · Vendors must comply with all regulations stated in the Vendor Participation Agreement
- A complete list of the products you intend to offer at the Market must be submitted
- All accepted Vendors must provide a Certificate of Insurance to PDP
- The criteria for vendor selection will include, but not be limited to: quality, uniqueness, pricing, and consistency with the Holiday Season
- Applications are requested by July 1 but will be considered on a rolling basis as capacity permits
