Vendor Classification & Pricing:	10x10' space
<b>MERCHANDISE VENDOR:</b> <i>Non-food items, hand crafts. Examples: jewelry, souvenirs, trinkets, pottery, glassworks, beauty products etc.</i>	\$35/market
<b>PROCESSED FOOD VENDOR:</b> <i>Packaged snacks &amp; desserts, misc. food products. Examples: jarred jams and sauces, jerky, sweets.</i>	\$35/market
<b>PREPARED FOOD VENDOR:</b> <i>Ready-to-eat meals and/or hot foods. <u>This category is limited and currently only open to Downtown establishments</u></i>	\$50/market
<b>ALCOHOL VENDOR:</b> <i>Bottled alcohol products of any type: beer, wine, cider, mead, spirits, etc. Products should not be available in state stores. Bottle sales and samples only, onsite consumption not permitted.</i>	\$50/market

### Vendor Qualifications:

- Vendors may apply to attend on select dates, subject to availability and are required to participate on the dates approved for and agreed upon.
- Applications received prior to April 23, 2021 will be reviewed for a first wave of acceptance.
- After April 23, applications must be submitted a minimum of two weeks prior to first requested date and will be considered on a rolling basis as capacity permits.
- Vendors are required to provide their own tents, weights, lights, and all other materials essential to their setup and operation.

- Vendors must adhere to latest local, state, and federal health and safety guidance and agree to safety regulations stated in the [Health & Safety Addendum to the Vendor Participation Agreement](#)
