Exhibitor Terms of Agreement

Exhibitor fee:

- Exhibitor fee is non-refundable and must be paid in prior to the invoiced deadline to confirm your participation and reserve your space for each event date.

PROHIBITED ITEMS:

PDP reserves the right to deny the sale of any items at its sole discretion.

- **No prepared or ready-to-eat foods.**
 - Downtown restaurants may inquire via above contact.
- **No Alcoholic beverages for onsite consumption.**
 - Alcohol vendors may offer bottle sales and samples only. No individual serving sizes.
- **No bikes permitted in the garage.**
 - Vehicle is required to participate.
- **No weapons.**
 - Including but not limited to firearms, knives, brass knuckles, explosives, weapons, etc.
- **No illegal substances.**
 - Or any items deemed inappropriate by PDP event staff.

RULES & REGULATIONS:

By submitting registration, you confirm you have read and agree to the terms of this agreement.

- **Arrival time: 8:00 a.m. – 9:30 a.m.**
 - Vehicle access begins at 8:00 a.m. and closes at 9:30 a.m.
 - Late arrivals will be turned away and no refunds will be given.
 - Participants must follow staff directions and will be parked in order of arrival.
 - Participants will be assigned one parking space for a standard vehicle and one adjacent parking space for booth display.
- **Standard vehicles only – Garage clearance: 6'4"**
 - No box trucks, trailers, or buses, or bikes. Vehicle is required for participation and one vehicle per registration.
 - Head in parking only, trunk should be accessible from the aisle
 - Display may not exceed more than **4 feet** beyond the vehicle trunk.
 - No tents permitted on interior garage levels. Sellers who plan to request a roof space may provide their own tent. Tent weights are mandatory and must be secured to each tent leg.
 - No idling, engines must be turned off once the vehicle is parked.
- **Alcohol exhibitor requirements:**
 - Limit 2 samples per patron. Must be 21 years of age to sample or purchase. Signage reflecting these rules must be posted onsite at booth.
 - Alcohol exhibitors are required to check for valid I.D. and staff must be RAMP certified.
- **No power is provided.**
 - No Wi-Fi available.
 - No amplified music, loudspeakers, bull horns, etc. permitted.
- **Load out: 2:00 p.m.**
 - Vehicles will not be permitted to be moved from their parking space until after event hours have ended at 2 p.m.
 - All sales must cease at the end of event hours at 2 p.m.
 - Sellers must remove all trash from their vending space and dispose of off-premise.
- **No Smoking in garage.**
- **Restrooms available on ground level.**
