### 2025 Vendor Fact Sheet

The Burgh Bazaar series (formally the Night Market) returns for the 2025 season and will be held on select Saturday evenings starting on June 21 and running through October 25, 2025. Live entertainment will be featured each week and the Market has availability for a wide variety of local, handmade artisans to participate throughout the season.

Vendor Classification & Pricing:	10x10' space	10x20' space
<b>MERCHANDISE VENDOR:</b> Non-food items, hand crafts. Examples: jewelry, souvenirs, trinkets, pottery, glassworks, beauty products etc.	\$50/market	\$100/market
<b>PROCESSED FOOD VENDOR:</b> Packaged snacks & desserts, misc. food products. Examples: jarred jams and sauces, jerky, sweets.	\$50/market	\$100/market
<b>FOOD TRUCK VENDOR:</b> Ready-to-eat meals and/or hot foods.	N/A	\$140/market
<b>ALCOHOL VENDOR:</b> Bottled alcohol products of any type: beer, wine, cider, mead, spirits, etc. Products should not be available in state stores. Bottle sales and samples. *Cocktail Sales Fee: \$75	\$75/market	N/A

#### Vendor Qualifications:

- Vendors may apply to attend on select dates, subject to availability
- Applications received prior to May 23, 2025 will be reviewed for a first wave of acceptance.
- After May 23, applications must be submitted a minimum of two weeks prior to the first requested date and will be considered on a rolling basis as capacity permits.
- Vendors are required to provide their own tents, weights, lights, and all other materials essential to their setup
- Vendors in PDP markets must use paper bags after sales are made in compliance with the City's [guidelines](#).
- All accepted Vendors must provide a Certificate of Insurance naming PDP and City of Pittsburgh as additionally insured by the provided deadline.
- Vendors must accept the terms of the Vendor Participation Agreement
- Alcohol Vendors must comply with all the regulations stated in the Alcohol Vendor Agreement
